1. Earth Day 2025 Proclamation

Staff shared more information about the Recycle with the Redhawks Basketball Game on February 11th, in collaboration with MU Sustainability, Rumpke, and Butler County Recycling. The city will be distributing recycling and composting bins at the game for City of Oxford residents. Staff provided sample bins for the commission to view and requested volunteers for extra assistance during the game.
