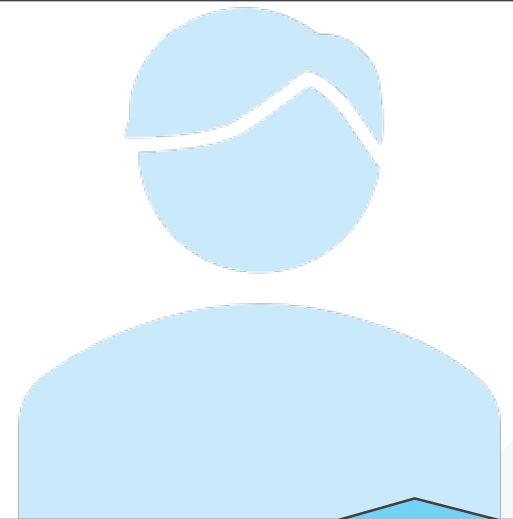

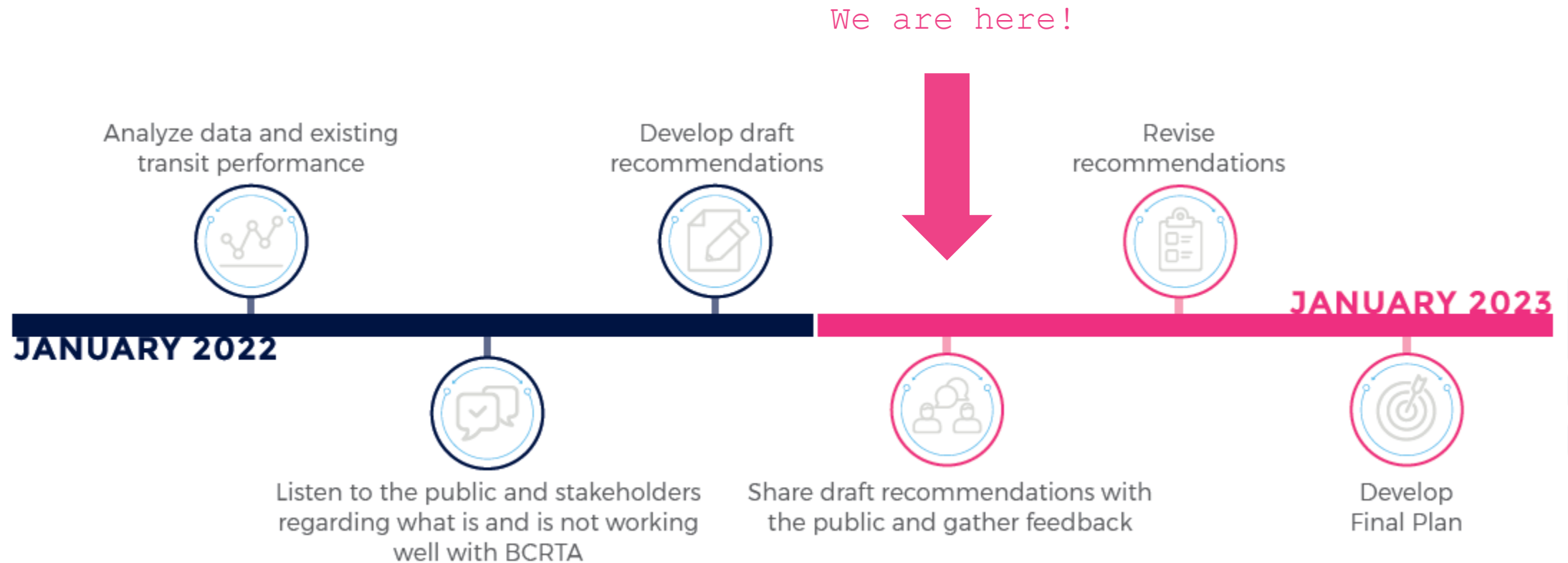

Bus Routes

Regional Routes

- 3 Routes; Middletown to Hamilton (R1); Hamilton to Oxford (R3); and Tri-County Mall to Hamilton (Job Connector)
- Weekday service only
- Hours depend on the route, but ~5:00am-10:00pm
- R1 & R3 operate every 60 minutes and Job Connector operates every 2 hours
- 42X West Chester & Downtown Cincinnati (contracted with SORTA)

Oxford Routes

- 8 routes, primarily focused on the Miami University campus
- Mostly weekday service, some weekend service
- Hours depend on the route, but ~7:00am-10:00pm
- Frequency depends on the route, but ~every 10-30 minutes

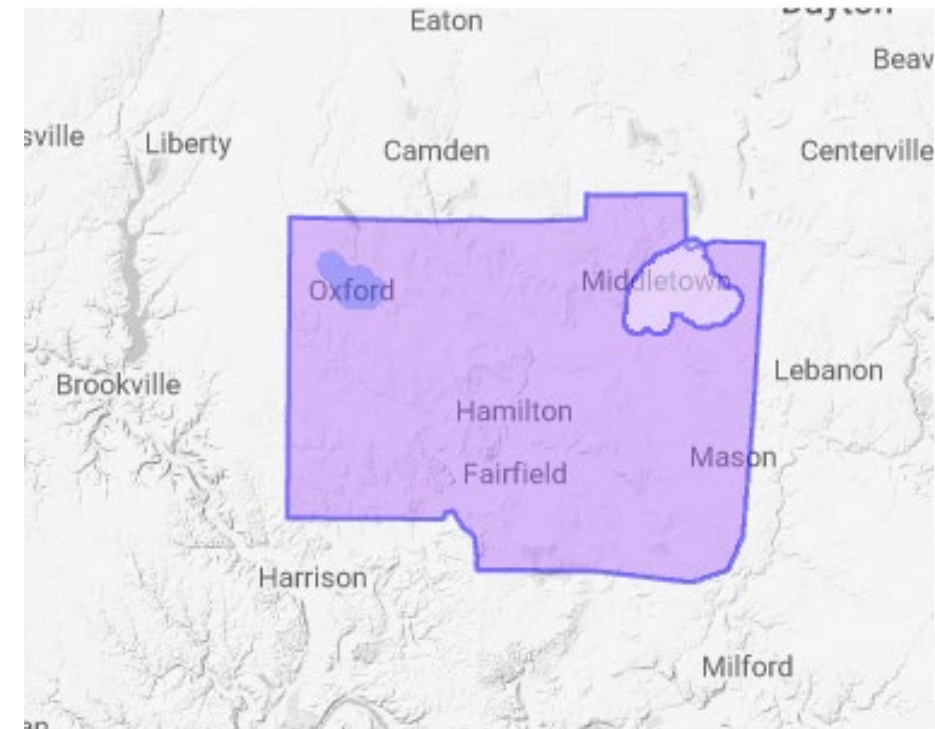
Middletown Routes

- 4 routes
- Weekdays and Saturdays
- 6:30am-6:30pm on weekdays and 8:30am-4:30pm on Saturday
- Every 60 minutes

On-Demand Service

- BGo Curb to Curb
 - Similar to Uber/Lyft
 - Miami University SafeRide: Free
 - BGo Service Area: \$5/trip
- BCARE Paratransit
 - Complementary paratransit service for persons who are not able to utilize the fixed route bus service due to a disability

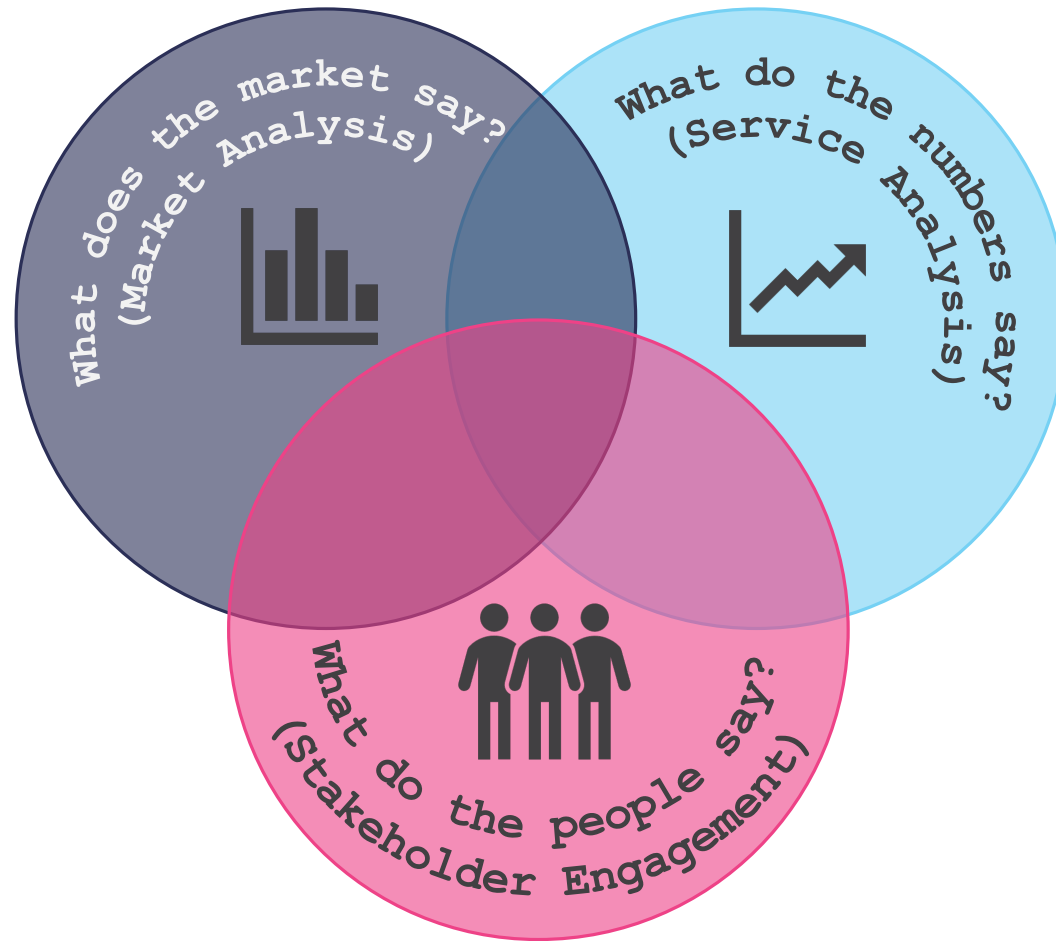

Project Approach



What we heard from the community about BCRTA service

Strengths:

- Fare-free system.
- Generally reliable and on-time service.
- Bus operators' friendliness and knowledge of routes and riders.

Areas of improvements to BCRTA service:

- Expanding service to residents/neighborhoods and having the same level of service available during the school year available year-round.
- More service to cities across the county and to Cincinnati vs. within cities.
- More service outside of typical commute hours.
- Bi-directional routes.
- Increased capacity on certain routes/during certain times of day.
- Finding more drivers to limit service cuts.
- Matching schedules, rider app, and operator tablet programming.

What we heard from the community about BCRTA service

Areas of improvement to BCRTA facilities:

- Real-time transit information.
- More shelters and benches.

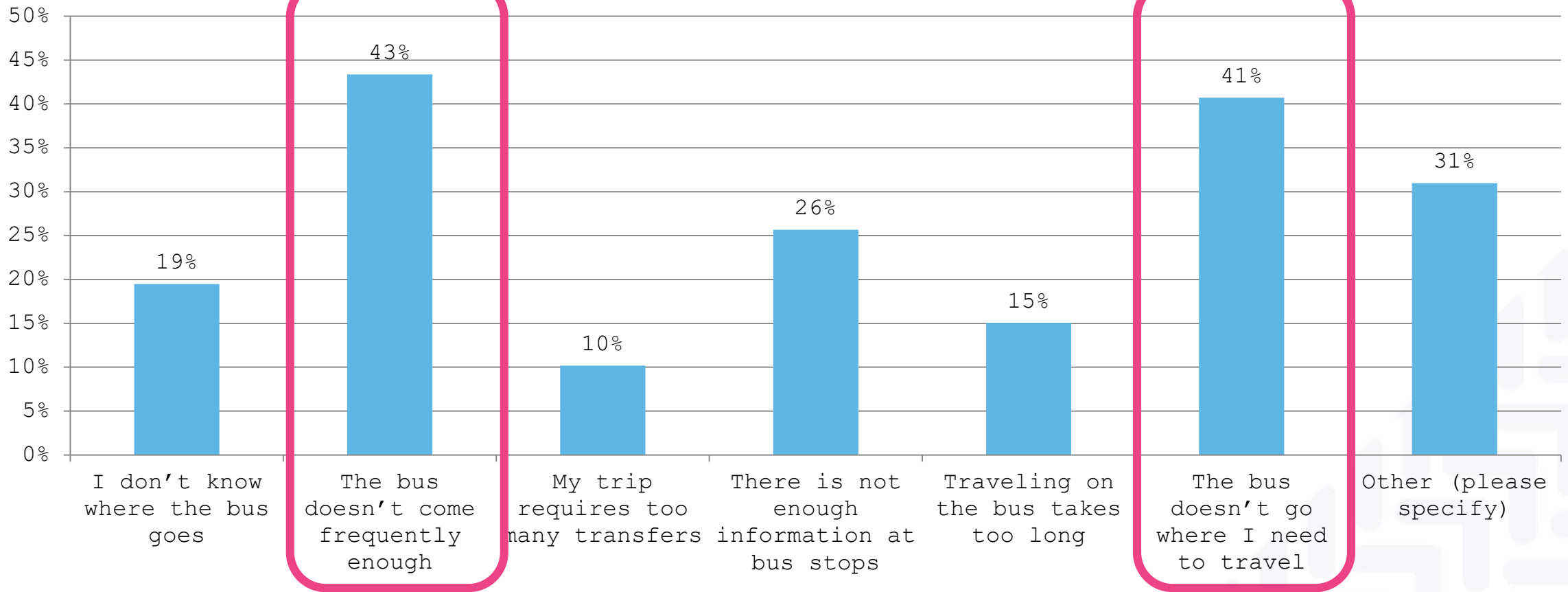
Areas of improvement for customer information and experience:

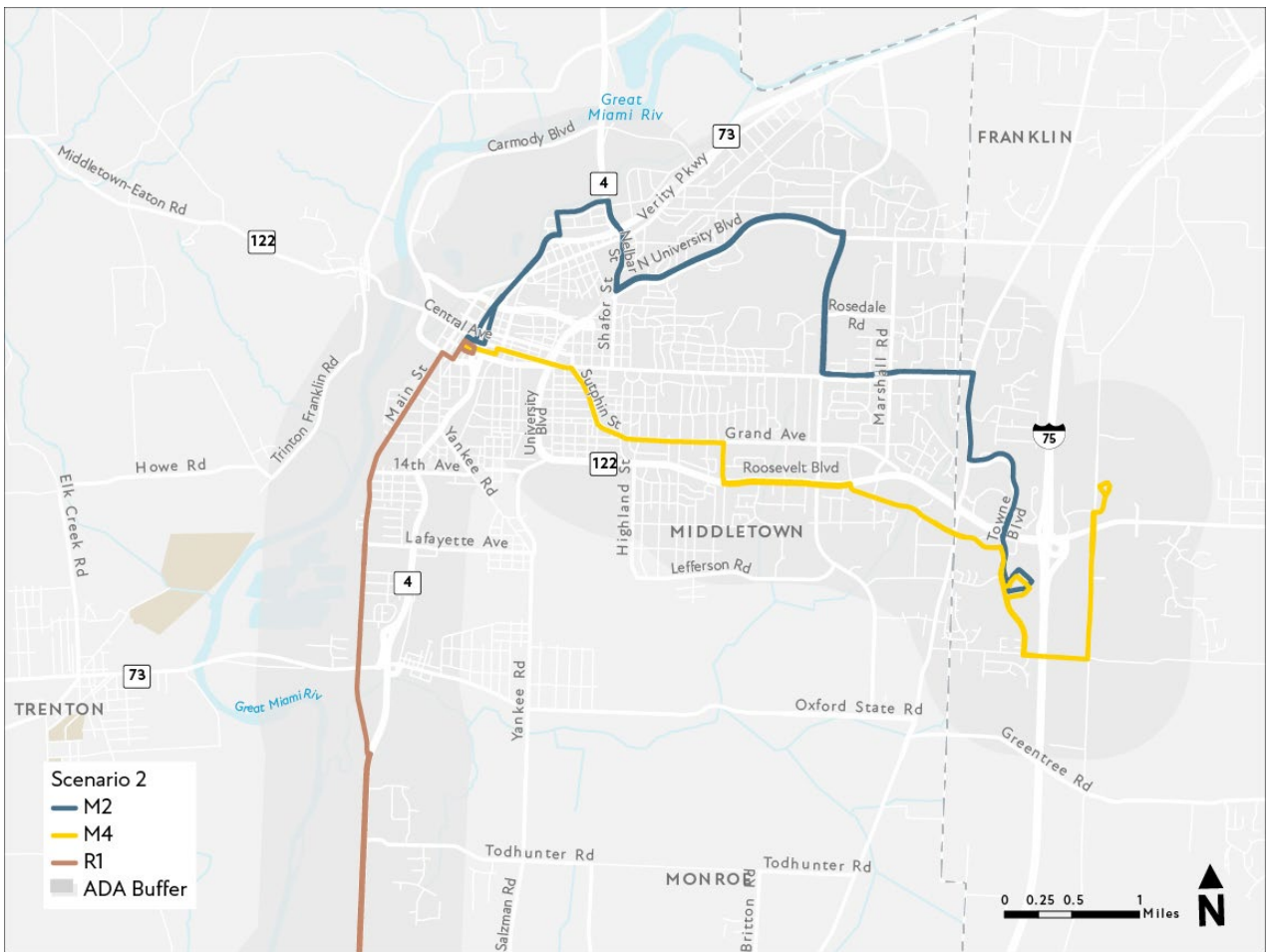

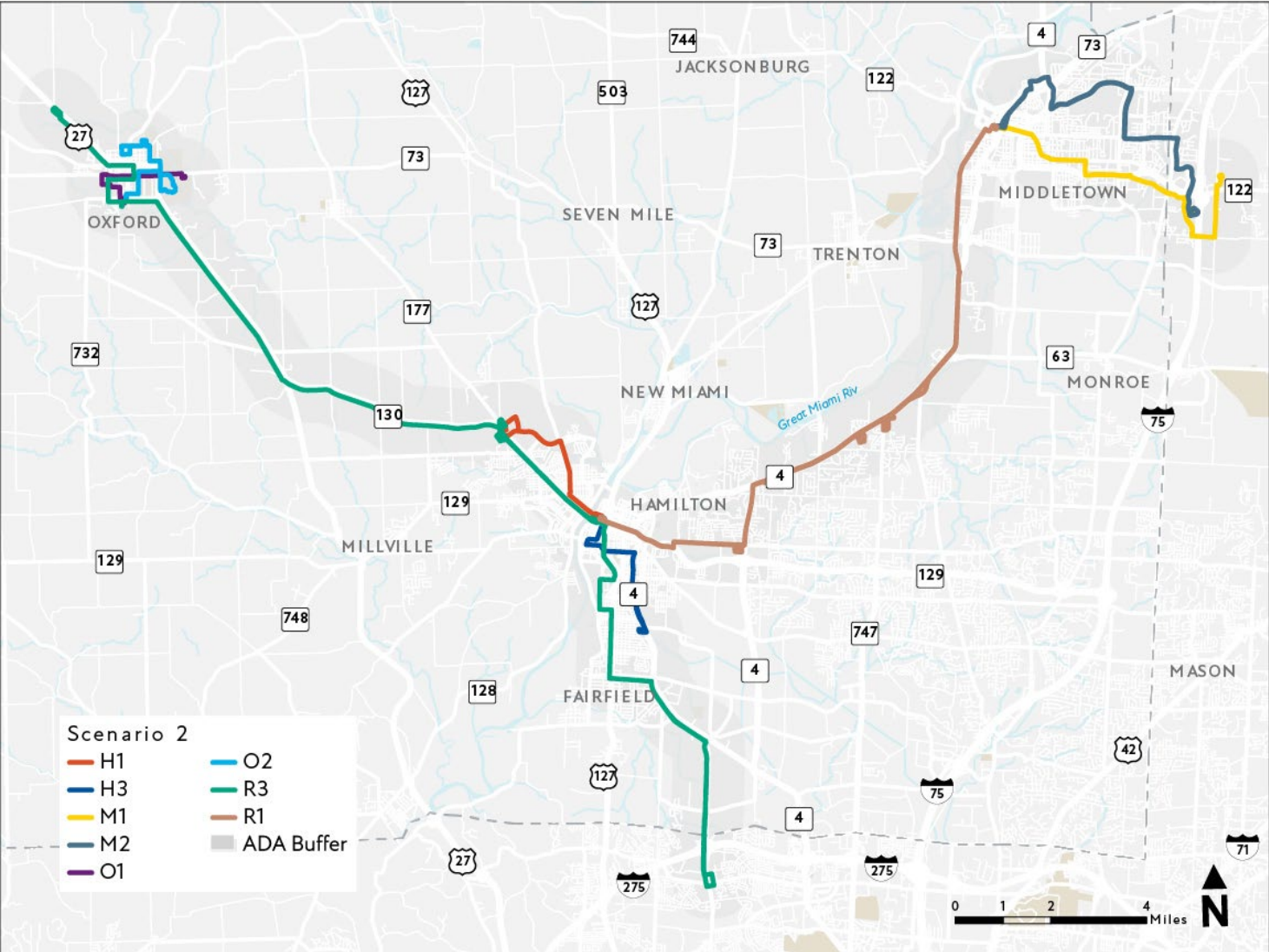
